Initial investment: EUR95,000

SEAI grant: EUR28,500

Annual savings: EUR16,200

Payback period: 4.1 years

But here's the kicker - they've actually started selling surplus energy back to the grid during peak afternoon hours. Talk about turning sunshine into cash flow!

How to Begin Your Solar Journey

First things first - get an energy audit. Most businesses I've worked with discover they're using 20% more power than necessary before even considering solar. The process typically involves:

Consumption analysis (look at those midnight refrigeration costs!)

Roof assessment (orientation matters more than you'd think)

Financial modeling (grants + tax breaks = faster ROI)

Pro tip: Pair solar with battery storage. Ireland's intermittent sunshine becomes less problematic when you can store daytime excess. The new Tesla Powerwall 3 handles 13.5kWh - enough to keep most SMEs running through the night.

A: The SEAI process has streamlined significantly. Most clients receive approval within 6-8 weeks.

A: New slimline panels are getting heritage approval. Check with local authorities first.

Q: What's the lifespan of a commercial system?

A: Most come with 25-year performance warranties. Properly maintained, they can last 35+ years.
